### SEX OFFENDER INFORMATION BULLETIN

**UPDATE: Blend will not be living at 124 Harrison Place  
and will remain at 169 W. Arndt Street**

The Fond du Lac Police Department is releasing the following information pursuant to Wisconsin State Statute 301.45 (Act 440) and 301.46 (2)(e) (Act 5), which authorizes law enforcement agencies to inform the public of a juvenile sex offender's release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been adjudicated as a delinquent of a sex offense. His previous criminal history places him in a classification level which reflects the potential to re-offend.

This sex offender has served the sentence imposed on him by the courts. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities, but it was not until passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notification. We believe the only person who wins if community notification ends is the sex offender, since sex offenders derive their power through secrecy.

**Brandon D. Blend** reached his mandatory release date from the Division of Juvenile Corrections on March 29, 2009, and has been residing in the City of Fond du Lac. The Fond du Lac Police Department was notified by the State Department of Corrections regarding a change of address for Blend. Blend is now residing at 124 Harrison Place #2 in the City of Fond du Lac.

Blend has a juvenile adjudication out of Fond du Lac County for 1st Degree Sexual Assault of a Child in 2006 when he was 14 years old. The assault was against a 15-year-old male victim while using force.

Special Conditions:

Blend has reached mandatory release and, therefore, is not currently under Department of Corrections supervision. However, he is required to register with the Wisconsin Sex Offender Registration Program until March 29, 2024.
