SEX OFFENDER INFORMATION BULLETIN

The Fond du Lac Police Department is releasing the following information pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to re-offend.

This sex offender has served the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location below. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notification. We believe the only person who wins if community notification ends is the sex offender, since sex offenders derive their power through secrecy.

The Fond du Lac Police Department is available to help you set up Neighborhood Watches and to provide you with useful information on personal safety. Gregory G. Wilkinson was convicted on one count of 1st Degree Sexual Assault of a Child in June of 1993. Wilkinson was sentenced to 7 years in prison for sexually assaulting a 13-year-old female acquaintance. Wilkinson was released on parole in December of 1996 and returned to prison in May of 1999 for parole violations. In February 2002, Wilkinson was civilly committed as a Sexually Violent Person under Chapter 980 and placed in a secure facility. Wilkinson was released from criminal and civil confinement in May of 2007 and was residing in the Van Dyne area until recently.

Special conditions of Gregory G. Wilkinson's release:

Wilkinson has reached mandatory release and, therefore, is not currently under Department of Corrections supervision. However, he is required to register with the Wisconsin Sex Offender Registration Program for life.

Gregory G. Wilkinson is living at 44 Doty Street in the City of Fond du Lac.
